## How to apply for an incentive

Step 1: Determine eligibility.

### Applicant

The applicant must be an active AES Indiana business customer with a qualifying Rate Code at the time of equipment installation.

## Applicant and installation

The application must be completed in full and signed prior to submission.

## Equipment and installation

In order to qualify for an incentive, you may not purchase or install equipment until receiving pre-approval from AES Indiana in the form of a Letter of Intent. Step 2: Complete application & attach supplemental documentation.

## Complete application

Unless noted otherwise, all fields must be completed on the application.

### Sign application

The application must be signed in the space provided on page 5.

# Attach supplemental documentation

Ensure you have attached a copy of all documentation to the application submission.

Documentation should include:

- A detailed scope of work
- Itemized costs for the proposed scope of work
- Savings calculations
- Facility description and equipment run hours

Program applications and required documents may be submitted using one of the three methods below.

Offer is valid for end-use AES Indiana customers with a qualifying rate code at the time of project completion. Qualifying rate codes include ISS, ISH, ISL, IPL, IPH or IHL. Equipment must have AES Indiana electric service. Incentive funds are limited and available on a first-come, first-served basis.

#### Verification

AES Indiana reserves the right to verify sales receipts and/or installations of equipment and that the equipment installed meets program requirements before granting incentives. A random inspection may be conducted to verify installations.

### Program modifications

AES Indiana reserves the right to alter or discontinue this incentive offer at any time without notice. Financial incentives are limited and are available on a first-come, first-served basis.

#### Incentive calculations

Incentive amount is calculated based on first-year energy savings. The incentives are earned at \$0.07-\$0.10 per kWh saved, depending on project type. Incentives will not exceed 50 percent of the total material and external labor cost and are limited to a maximum of \$1,000,000 per project at a service ID and/or building behind a master meter. Total combined Custom and Prescriptive Incentives are capped at \$1,000,000 per customer per calendar year.

The AES Indiana Business Rebates & Incentives program incentive cannot be granted without prior completion of this application and subsequent approval by AES Indiana. Energy service companies or contractors may assist in preparing the application, but an authorized representative of the AES Indiana customer must sign this application to be eligible to participate in the AES Indiana Business Rebates & Incentives program. Completion of this application does not guarantee the approval of a Custom Incentive.

Do not begin your Energy Efficiency Project(s) or purchase equipment until you receive written approval in the form of a Letter of Intent from AES Indiana.

Eligibility for Custom Incentives on LED lighting is limited to products that appear on one of the following qualified product lists (QPLs):

- ENERGY STAR<sup>®</sup> qualified commercial LED lighting
- DesignLights<sup>™</sup> Consortium QPL
- If your products are not included on the ENERGY STAR or DesignLights Consortium QPLs, please email us at custom@aesindianarebates.com or call 888-982-7071 to speak with a program representative.

Product installation must be in accordance with manufacturer's recommendations.

Once all documentation is received by AES Indiana (a site inspection may be completed if necessary), AES Indiana will complete an engineering review and indicate the anticipated Custom Incentive amount in a Letter of Intent based on the projected energy savings. Upon completion of the project and verification of installation and operation of the energy-saving measures, AES Indiana will issue a Custom Incentive check in the amount indicated in the Letter of Intent, or adjust if the project varies from the information originally submitted.

Measures must meet minimum cost-effective requirements as determined by AES Indiana. Installed energy efficiency measures must have at least a five-year measure life and a one-year minimum payback period prior to incentives.
