The EAP had been sent to Morgan County EMA via email on 10/7/2025. Construction on Ponds A-C began May 2025. No revisions were required to the EAP based on this meeting/review. There was discussion regarding the upcoming closure/draft closure permit for Ponds D&E pending with IDEM, which will begin closure when Ponds A-C are closed.

Note: no ash has been sluiced to the ash ponds since 02/2016 when the new CCGT facility was constructed. Ash ponds have been dry since early 2018.
