



2021 AES Indiana Appliance Recycling Tablet SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT IMPROVE YOUR CHANCES OF WINNING. 1. Eligibility: The 2021 AES Indiana Appliance Recycling Tablet Sweepstakes ("Sweepstakes") begins at 12:01 a.m. CDT on June 15, 2021 and ends at 11:59:59 PM CDT on July 31, 2021 (the "Sweepstakes Period"). The Sweepstakes is open only to persons who are (18) years of age or older at the time of entry. Entrants must be AES Indiana customers in good standing during the entire Sweepstakes Period and at the time of the drawing. Employees, independent contractors, and any other persons or companies who receive compensation from Appliance Recycling Centers of America (ARCA) 7301 Ohms Lane, Suite 320, Edina, MN 55439 or AES Indiana and the immediate family (spouse, civil union/domestic partners, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year) of all such persons are not eligible to participate in this Sweepstakes. Participation in the Sweepstakes constitutes entrant's full and unconditional agreement to, and acceptance of, these Official Rules. The postcard must include your First Name, Last Name, Street Address, City, State, Zip, Phone Number, and AES Indiana Customer Account Number. Mail-in entries must be postmarked no later than July 31, 2021. Participating in the AES Indiana Appliance Recycling Program will not increase your chances of winning. Limit one (1) entry per AES Indiana residential account number, regardless of method of entry. In the event that multiple entries are received for the same AES Indiana account number, the authorized account owner at the time of entry will be considered the entrant. All entries become the property of AES Indiana and will not be acknowledged or returned. By entering, entrants acknowledge compliance with these Official Rules, including all eligibility requirements.

3. Random Drawing: Two (2) Grand Prize Winners will be selected in a random drawing from all eligible entries received on or about August 15, 2021. The drawing will be conducted by Appliance Recycling Centers of America, 7301 Ohms Lane, Suite 320, Edina, MN 55439. Two winners will be selected. Winners will be notified by phone or mail on or about August 21, 2021. Failure to respond to the initial verification within (10) days of notification will result in disqualification and selection of an alternate potential winner in a random drawing of all remaining valid entries received. AES Indiana's decisions as to the administration and operation of the Sweepstakes and the selection of the potential winner are final and binding in all matters related to the Sweepstakes.

4. Prizes/Odds: Grand Prize (2): Tablets. Odds of winning depend upon the total number of entries received. Two winners will be selected.
