## GROUNDWATER MONITORING SYSTEM CERTIFICATION IPL PETERSBURG GENERATING STATION RWS III LANDFILL

ATC Group Services LLC ("Consultant") has been retained by Indianapolis Power & Light Company (IPL). to review groundwater monitoring system design and construction in order to assess whether the above-referenced coal combustion residuals (CCR) landfill meets the groundwater monitoring system design and construction requirements set out in 40 CFR § 257.91. Presented below are the project background, limitations, and certification.

## 1.0 BACKGROUND

Pursuant to 40 CFR § 257.90(b), owners and operators of new and existing CCR landfills, and new and existing CCR surface impoundments, and all lateral expansions of a CCR unit must install a groundwater monitoring system. 40 CFR § 257.91 requires owners and operators of a CCR unit to install a groundwater monitoring system that, relying on site-specific technical information, consists of a sufficient number of wells, installed at appropriate locations and depths, to yield groundwater samples from the uppermost aquifer that accurately represent the quality of background groundwater that has not been affected by leakage from the CCR unit and accurately represent the quality of groundwater passing the waste boundary of the CCR unit.

Pursuant to 40 CFR § 257.91(f), the owner or operator must obtain a certification from a qualified professional engineer stating that the groundwater monitoring system has been designed and constructed to meet the requirements of 40 CFR § 257.91, including the performance standards specified in 40 CFR § 257.91(a), based on the site-specific information specified in 40 CFR § 257.91(b). If the groundwater monitoring system includes the minimum number of monitoring wells specified in 40 CFR § 257.91(c)(1), the certification must document the basis supporting this determination.

In support of Consultant's assessment, Consultant completed an evaluation of the groundwater monitoring system for the above-referenced CCR unit and determined that sufficient information is available to make the certification required under 40 CFR § 257.91(f).

This groundwater monitoring system consists of one upgradient well and seven downgradient monitoring wells, installed at locations that represent the quality of background groundwater and the quality of groundwater passing the waste boundary. The groundwater monitoring wells are installed in the uppermost saturated zone comprised of unconsolidated deposits and weathered bedrock.
